

On the financial scene, China's economy is projected to grow by 5% in 2024, according to the IMF, up from an earlier forecast of 4.6%. This revision follows a strong first quarter and recent policy measures aimed at stabilizing growth. However, the IMF warns that growth is expected to slow to 3.3% by 2029 due to an aging population and slower productivity gains. The revised forecast aligns with Beijing's growth target of "around" 5%, supported by a first-quarter growth of 5.3%.

Another important development this month was the proposed raising of tariffs on Chinese electric vehicles (EVs) by the European Union on July 4th unless Beijing agrees to a "solution" to subsidies that the bloc says are causing its markets to be distorted. The European Commission said that they will increase the taxes on Chinese car companies to 38% instead of

The European Commission says that Chinese-built EVs are 20% cheaper than European ones, and that has helped imports of EVs into the EU skyrocket in recent years. The EU says that China is unfairly supporting green tech exports, including solar panels, batteries and wind turbines.

TIANJIN PORT LAUNCHES NEW ROUTE TO SOUTH AMERICA'S EAST COAST



A new sea route from Tianjin Municipality to the east coast of South America became operational on Monday, to facilitate trade between China and countries of the region with upgraded transport capacity. China and South America have the longest sea route crossing the Pacific Ocean, and the new service will promote business and trade cooperation, experts noted.

BEIJING-TIANJIN-HEBEI REGION TO ADD 100 INTER-PROVINCIAL GOVERNMENT SERVICES



As part of its efforts to optimize business environment, the Beijing-Tianjin-Hebei region plans to add over 100 inter-provincial government services, according to a plan recently released by the Beijing municipal government. As of now, a total of 203 government services are processed to the same standard across the region and 234 service items are provided on an inter-provincial basis...

BEIJING-TIANJIN-HEBEI REGION LAUNCHED UNIFIED CARD FOR SERVICES



A unified card offering access to multiple services was launched on Sunday, providing residents in the Beijing-Tianjin-Hebei region with access to 22 major social security services, 193 tourist areas, 23 museums, 171 libraries, 64,000 hospitals and 3,909 bus routes. The initiative was announced during a symposium in Tianjin attended by key leaders from the Communist Party of China and regional governments that also featured a project signing ceremony.

AUTONOMOUS FREIGHT TRANSPORT LAUNCHED IN BEIJING-TIANJIN-HEBEI REGION



An autonomous artery freight transport has been launched on the expressway in the Beijing-Tianjin-Hebei region, a major economic zone in north China, marking significant progress in cross-provincial autonomous logistics. On Monday, a fully-loaded heavy-duty truck, which was equipped with self-driving capabilities and powered by hydrogen embarked on a journey along the Beijing-Tianjin-Tanggu expressway from Majuqiao Logistics Park in Beijing, passing through Langfang in Hebei Province, and finally arriving at Tianjin Port in eastern Tianjin's Tanggu District.

FIRST OFFICIAL CROSS-BORDER WAREHOUSE IN BEIJING-TIANJIN -HEBEI LANDED IN TIANJIN



Cainiao and AliExpress's first official cross-border warehouse in Beijing-Tianjin-Hebei have landed in Tianjin. The warehouse will greatly reduce the pressure on cross-border merchants in North China to prepare goods, so that more merchants can join AliExpress semi-hosting without worry.

TIANJIN INT'L CRUISE HOME PORT RECEIVES OVER 100,000 PASSENGERS IN 2024




As the cruise ship Dream set sail on Wednesday, Tianjin International Cruise Home Port has received more than 100,000 international cruise passenger trips in 2024.

BEIJING PLANS TO OPEN COMMUTER AIR ROUTES TO XIONGAN AND TIANJIN



The Beijing Municipal Bureau of Economy and Information Technology has proposed a plan to develop China's low-altitude air flight industry and is seeking public opinion. The plan is for intercity commuting routes to be established between Daxing Airport and Xiongan New Area, and Beijing Capital International to Tianjin and Langfang. The call for public opinion sets specific development goals, aiming for the number of enterprises related to the low-altitude industry to exceed 5,000 by 2027.

TIANJIN UNIVERSITY DEVELOPS SUPER COLD-RESISTANT E-SKIN FOR POLAR EXPLORATION

This innovation represents a great boon for the country's polar exploration. The article about the highly stretchable, self-healing, and sensitive electronic-skin has been published on the Journal of the American Chemical Society, according to Zhang Lei and Yang Jing, who led the research team at the School of Chemical Engineering and Technology of Tianjin University.

CHINA EXTENDS SHORT-TERM VISA EXEMPTION FOR 12 COUNTRIES UNTIL END OF 2025



China has decided to extend visa exemption entry for citizens from 12 countries including France on short-term visits to China until the end of 2025. Chinese President Xi Jinping made the announcement during the closing ceremony of the Sixth Meeting of China-France Business Council.

CANTON FAIR CONCLUDES WITH RECORD NUMBER OF FOREIGN BUYERS



The 135th China Import and Export Fair, also known as the Canton Fair, concluded Sunday in south China's Guangzhou, with a record number of international buyers in attendance, according to the fair organizer. A total of 246,000 overseas buyers from 215 countries and regions participated in the offline fair, up 24.5% from the previous session.

CHINA IMPLEMENTS VISA-FREE POLICY FOR FOREIGN TOURISTS ENTERING BY CRUISE SHIPS FROM MAY 15TH



Starting from Wednesday, foreign tourist groups (consisting of two or more people) traveling by cruise ship and organized by domestic travel agencies can enter Chinese mainland without a visa as a whole group through the designated ports in 13 cities including Tianjin, Dalian in Liaoning Province, Shanghai, Lianyungang in Jiangsu Province, Wenzhou and Zhoushan in Zhejiang Province, Xiamen in Fujian Province, Qingdao in Shandong Province, Guangzhou and Shenzhen in Guangdong Province, Beihai in Guangxi Zhuang Autonomous Region, Haikou and Sanya in Hainan Province, said the National Immigration Administration at a press conference on Wednesday.

UNIONPAY ONLINE PAYMENT NOW AVAILABLE IN 60+ MUST-HAVE APPS FOR GLOBAL VISITORS TO CHINA



UnionPay has recently joined hands with more than 60 online merchants, including Meituan, Ctrip, JD.com and Pinduoduo, to enable online payment for UnionPay cards issued outside China's mainland, covering key online use cases such as shopping, transit, flight booking, and utility payment. Drawing on the product and service innovations driven by Project Excellence 2024, UnionPay is dedicated to providing diverse and seamless payment services for international customers.

CHINA ORDERS HOTELS NOT TO REFUSE FOREIGN GUESTS



Chinese authorities ordered hotels across the country on Friday not to refuse foreign guests, based on the excuse of the hotels' lacking relevant qualifications. The hotels are being guided and supervised to improve their foreign guest reception services following some complaints from netizens from Nigeria, the UK, Pakistan and other countries. After receiving the complaints about some hotels refusing foreign guests due to "lacking qualifications for receiving foreign guests," or "not knowing how to input information into the systems," especially in small cities, the Ministry of Public Security (MPS), the Ministry of

Commerce (MOCFOM), and the National Immigration Administration have carefully studied the situation and come up with a slew of targeted measures.

THIS EXAM WILL OPEN TO FOREIGN NATIONALS FROM JUNE



The Ministry of Finance announced on Tuesday (May 14th) that starting June 1st this year, foreign nationals who are legally working and residing in China will be able to take the accounting professional qualification exams. These exams will follow the same standards as those for domestic candidates. Foreign nationals who meet the registration requirements for the accounting professional qualification exams can register at the nearest convenient location. Additionally, accounting work experience gained abroad by foreign nationals will be counted towards their accounting work experience requirements.

ANOTHER COUNTRY ANNOUNCES UNILATERAL VISA EXEMPTION FOR CHINESE CITIZENS



The Cuban government announced on Saturday that it will adopt a visa-free policy for Chinese citizens holding ordinary passports, starting this month. The announcement was made by Tourism Minister Juan Carlos Garcia during the 42nd Cuban International Tourism Fair (FITCuba

2024), which was held in the seaside resort of Cayo Coco in the province of Ciego de Avila.

8 MORE MAINLAND CITIES TO JOIN HK, MACAO INDIVIDUAL VISIT SCHEME



Eight more cities on the Chinese mainland will be eligible to issue individual travel endorsements for trips to Hong Kong and Macau special administrative regions starting from May 27, according to the National Immigration Administration on Saturday. The adding of these eight cities, namely Taiyuan in Shanxi Province, Hohhot in the Inner Mongolia Autonomous Region, Harbin in Heilongjiang Province, Lhasa in the Xizang Autonomous Region, Lanzhou in Gansu Province, Xining in Qinghai Province, Yinchuan in the Ningxia Hui Autonomous Region, and Urumqi in the Xinjiang Uygur Autonomous Region, was approved by the State Council.

CHINA SETS NEW RULES TO WOO FOREIGN CRUISE SHIPS TO LOOK ITS PORTS




China is revising its rules for the international cruise industry to encourage ships to dock at its ports for supplies as the country seeks to lure foreign travelers and boost tourism. The new regulations, taking effect June 1, clarify requirements for

resupplying vessels, specify rules on providing materials such as drugs, medical devices and duty-free tobacco products, and streamline customs procedures, Wang Zhenjiang, China's vice minister of justice, said at a press conference in Beijing.

254 CITIES ENACTING NEW NON-SMOKING REGULATIONS



China is ramping up its efforts to control smoking with 44 cities newly introducing or revising regulations in 2023, bringing the total number of cities with relevant regulations to 254 nationwide, according to national health authorities. According to the Xinhua News Agency, 24 regions at the provincial level in China have rolled out regulations on smoking, with the proportion of the population protected by comprehensive smoke-free regulations continuing to increase, experts from the National Health Commission (NHC) released the data on Saturday ahead of the World No Tobacco Day on May 31.

Xiang, Xiang, the celebrity female giant panda born in Japan, turned 7 years old on Wednesdayl Crowds of visitors, including hundreds from Japan, flocked to the Ya'an base of the China Conservation and Research Center for the Giant Panda in Sichuan Province to join in the festivities. Xiang Xiang was born on June 12, 2017 at Tokyo's Ueno Zoo to Shin Shin (female) and Ri Ri (male), two giant pandas on loan from China. She returned to China in February 2023 according to the loan agreement.

Chinese authorities have allocated 916 million yuan (about \$126 million) to flood and drought response work in the country's southern and northern regions, and to support disaster relief efforts, the Ministry of Finance said on Wednesday. The figure includes 499 million yuan to support flood control, relief efforts and safety measures in Guangdong, Fujian, Guangxi, Guizhou, Yunnan, Zhejiang, Jianoxi, Hunan and Hubei.

China saw 110 million domestic trips during the three-day Dragon Boat Festival holiday, up 6.3% from the previous year, according to the Chinese Ministry of Culture and Tourism. Tourists also spent 40.35 billion yuan over the holiday that stretched from Saturday to Monday, an increase of 8.1% from the same period last year.

China will build 3,000 more charging piles at highway service stations nationwide this year, according to a senior official. The country had built 9,92 million charging piles by the end of May this year, a growth of 56% year on year, Li Chao, a spokeswoman of the National Development and Reform Commission, said at a press briefing on Tuesday.

Jiang Ping, a 17-year-old student in China, has sparked debate on mathematics and education after she was shortlisted for the 2024 Alibaba Global Mathematics Competition finals. Ranking 12th out of a total of 801 finalists, Jiang is the only female in the top 30 on the list released by DAMO Academy, a research and development branch of Alibaba Group. She is also the first secondary vocational school student to enter the finals since the competition was launched in 2018.

The Yangtze River Delta, an economically vibrant region in China, on Saturday saw the operation of its 1st railway loop line, threading the metropolis of Shanghai with major cities in the regional cluster Coded G8388, the first train service on the loop railway was launched from Shanghai Railway Station at 10:27 a.m. and for a full loop, the train is scheduled to travel for eight hours and nine minutes on a track that extends more than 1,200 kilometers.

In 2023, China recorded a historic surge in voluntary blood donations, with 16.99 million donations, a 5.9% increase from the previous year, according to China's National Health Commission (NHC) data. The NHC reported that the total blood volume of voluntary donations over the past year expanded by 4.8% and also hit a new high.














WHAT IS CHINA'S PANDA DIPLOMACY AND HOW DOES IT WORK?

During a recent visit to Australia, Chinese Premier Li Qiang made a classic goodwill gesture that boded well for relations between the two countries: he offered to send pandas.

The offer comes as ties between Australia and its largest trading partner improve after a diplomatic dispute that lead to China imposing a raft of restrictions on Australian agricultural and mineral exports in 2020.

Native to China, pandas have, through the years, become "envoys of friendship", and in China's outreach to countries, it gifts the animals in the name of panda diplomacy.

WHEN DID PANDA DIPLOMACY START?

Since its founding in 1949, the People's Republic of China has used panda diplomacy to boost its international image, either by gifting or lending pandas to foreign zoos as goodwill animal ambassadors.

In 1957, former Chinese leader, Mao Zedong, gifted a panda, Ping Ping, to the former Soviet Union to celebrate the 40th anniversary of the October Revolution that ushered in the Soviet regime.

To further cement ties with its socialist allies, China dispatched another panda to the Soviet Union in 1959, and five more to North Korea between 1965 and 1980.

In 1972, Beijing gifted two pandas, Ling Ling and Hsing Hsing, to the United States after then President Richard Nixon's historic visit, as a sign of normalised China-U.S. relations and marking a pivotal moment for China's foreign policy.

Since then, other countries, including Japan, France, Britain and Spain, have also been given pandas.

Since 1984, China has stopped gifting pandas due to their dwindling numbers and instead has begun loaning them to overseas zoos, often in pairs, for 10 years, with an annual fee of up to about \$1 million.

While keeping pandas can be costly for zoos, the animals are seen as drawcards for visitors, and this helps generate income

The pandas typically return home to southwest China after the loan agreement ends. Panda cubs born overseas are no exception, and would be sent home between the age of two and four to join a Chinese breeding programme.





HOW DOES IT WORK?

China has a history of using pandas to reward its trading partners. A 2013 Oxford University study said the timing of China's lease of pandas to Canada, France and Australia "coincided " with uranium deals and contracts with these countries.

The panda agreements with other countries, including Singapore, Malaysia and Thailand, also coincided with the signing of free-trade agreements.

However, pandas are sometimes also used to express China's displeasure with a nation. In 2010, China recalled two U.S.-born pandas, Tai Shan and Mei Lan, after Beijing warned Washington against a scheduled meeting between then-President Barack Obama and the Dalai Lama, whom Beijing views as a dangerous separatist.

In a recent downturn in bilateral ties, Ya Ya, on loan to the U.S. for 20 years, was returned in April 2023. Concerns over her health had also fanned nationalist

sentiment on China's social media, with animal advocates accusing the Memphis Zoo in Tennessee of providing inadequate care for the animal.

In November last year, three other pandas were returned, leaving only four giant pandas on U.S. soil. Chinese President Xi Jinping hinted at the time that he was open to sending more pandas to the U.S. after meeting with President Joe Biden in California, a gesture seen as Chinese willingness to improve ties.

ARE PANDAS STILL ENDANGERED?

China's domestic conservation programmes have seen the status of pandas improve from endangered to vulnerable.

The population of giant pandas in the wild has grown from around 1,100 in the 1980s to 1,900 in 2023.

There are currently 728 pandas in zoos and breeding centres around the world.

Fresh Malaysian durians to go to China as trade deals are signed during Premier Li's visit

Fresh Malaysian durians will soon be sent to China as the two countries signed a number of trade and economic deals during a visit by Premier Li Qiang to celebrate a half-century of diplomatic relations.

Li held private talks with Malaysian Prime Minister Anwar Ibrahim in the government administrative capital of Putrajaya before they met with their delegations. The two leaders witnessed the signing of various pacts, including a new five-year deal for economic and trade cooperation that officials said would bolster links between industries in priority sectors like high-level manufacturing and the digital economy.

The two sides also agreed on a protocol for measures that will allow Malaysia to export to China fresh durian, a spiky tropical fruit with a strong odour and known for its creamy pulp.

Exporting fresh durians to China will open a new market for Malaysia, which began selling durian pulp and paste to China in 2011 and frozen durian whole fruits in 2018. Malaysia's frozen durian export value to China surged from 170 million ringgit (\$36 million) in 2018 to nearly 1.2 billion ringgit (\$255 million) last year.

Li, the first Chinese premier to visit Malaysia since 2015, was given a red carpet welcome, and said upon his arrival that the two nations' 50-year anniversary was a new starting point to deepen links and increase exchanges.

"China is ready to work with Malaysia," Li said in a statement. Li is China's No. 2 leader after President Xi Jinping.

While trade dominated the talks, the prickly issue of territorial claims in the South China Sea was also raised.

The two leaders agreed that China and claimant countries in Southeast Asia should tackle the maritime dispute "independently and properly" through dialogue and cooperation, and via bilateral settlement.

Other agreements signed aim to promote investment in the digital economy and green development, combat transnational crime, and boost housing and urban development, higher education, people-to-people exchanges in science and technology, tourism and cultural cooperation.

Trade with China, Malaysia's No. 1 trading partner since 2009, made up 17% of Malaysia's global trade, valued at \$98.8 billion last year.

Anwar, who visited China twice last year, has sought to move closer to Beijing even while engaging the U.S. as a key ally. While speaking at a forum in Tokyo in May, Anwar stressed that Beijing is too close, too important and too strategic to ignore.

Ahead of Li's visit, Anwar told Chinese media that Malaysia planned to join the BRICS bloc of developing economies but didn't give details. The plan was confirmed by Malaysian officials. The bloc's core members are Brazil, Russia, India, China and South Africa, who seek a fairer world order currently dominated by Western nations. The bloc expanded with Egypt, Ethiopia, Iran, Saudi Arabia and the United Arab Emirates invited to become members this year. Some 40 countries have also expressed interest.


"Joining BRICS doesn't mean Malaysia will lose its strategic ambiguity between Beijing and Washington. It merely means an additional platform to give it a bigger voice as a middle power," said James Chin, professor of Asian studies at Australia's University of Tasmania.

Li also had an audience with King Sultan Ibrahim Iskandar. He and Anwar later broke ground for a terminal station for the East Coast Rail Link, which connects Malaysia's west coast to eastern rural states and is a key part of China's Belt and Road infrastructure initiative.

Li said at the ceremony that the railway was the largest single transportation infrastructure project undertaken by a Chinese company overseas. Once it is completed, he said, China is willing to work with Malaysia to develop projects along the railway line to drive more commerce, logistics and tourism. Li said the rail line also could potentially be linked to Thailand, and subsequently to southern China.

The project was suspended in 2018 after Malaysia's long-ruling coalition was toppled in a historic general election over a massive corruption scandal. It was subsequently revived after the Chinese contractor agreed to cut the construction cost by one-third, and is now due to be completed by the end of 2026

CHINA'S YOUTH UNEMPLOYMENT RATE FALLS, **SHOWING IMPROVEMENT IN JOB MARKET**

China's youth unemployment rate, excluding students aged 16 to 24, fell to 14.7% in April from 15.3% in March, according to the National Bureau of Statistics (NBS). The jobless rate for those aged 25 to 29 also decreased slightly to 7.1% from 7.2%.

The NBS reported a generally stabilizing trend in overall unemployment data, reflecting the country's stable economic recovery. Key metrics for industry, exports, and employment improved in April compared to

Analysts attribute the job market recovery to targeted government measures rolled out in the first quarter, which created new opportunities for job seekers. Li Chang'an, a professor at the University of International Business and Economics, noted that while the youth unemployment rate improved, more government efforts are needed to support this group, especially with a record 11.79 million college graduates entering the job market in 2024. From January to April, the average surveyed urban unemployment rate was 5.2%, down from 5.4% in the same period in 2023. China aims to create over 12 million urban jobs this year and keep the urban unemployment rate around 5.5%. In the first quarter, 3.03 million new jobs were created, indicating a positive start for the employment market.

IMF UPGRADES CHINA'S GDP GROWTH FORECASTS AND INFLATION STEADY

China's economy is projected to grow by 5% in 2024, according to the IMF, up from an earlier forecast of 4.6%. This revision follows a strong first guarter and recent policy measures aimed at stabilizing growth. However, the IMF warns that growth is expected to slow to 3.3% by 2029 due to an aging population and slower productivity gains. The revised forecast aligns with Beijing's growth target of "around" 5%, supported by a first-quarter growth of 5.3%. Major financial institutions like BNP Paribas, Goldman Sachs, and Citi have also upgraded their forecasts to 5%, citing the robust first-quarter performance. Despite the optimistic forecast, significant challenges remain. The ongoing property crisis continues to hamper economic recovery, affecting stock markets and the Chinese yuan. The IMF highlighted the need for comprehensive policy measures to address the sector's issues, including support for buyers of unfinished homes to facilitate the exit of insolvent developers. While recent indicators suggest China has managed some near-term risks, concerns about the sustainability of this recovery persist. Retail sales in April grew at their slowest pace since December 2022, and new home prices fell at their fastest rate in nine years. Gita



Gopinath, IMF's First Deputy Managing Director, emphasized the importance of balancing support for domestic demand, inflation mitigation, and debt management. She also noted that core inflation in China is expected to rise to an average of about 1% in 2024.

China's Inflation Rate

China's annual inflation rate held steady at 0.3% in May 2024, the same as April and below market forecasts of 0.4%. This marks the fourth consecutive month of consumer inflation, indicating a continuing recovery in domestic demand. Non-food prices grew by 0.8%, slightly down from 0.9% in April. Inflation remained stable for clothing (1.6%), housing (0.2%), and health (1.5%), while education costs saw a slight decrease (1.7% from 1.8%). However, transport prices fell by 0.2%, reversing a 0.1% gain in April when some local governments had increased utility and

train ticket prices. On the food front, prices declined for the eleventhmonth, but the fall was the smallest since February, at -2.0% compared to -2.7% in April. Core consumer prices, which exclude food and energy costs, rose by 0.6% year-on-year, a slight drop from the 0.7% increase in April.

Monthly, the Consumer Price Index (CPI) declined by 0.1%, marking the second monthly decline this year and missing the consensus expectation of no change. This follows a 0.1% rise in April. The stable inflation rate reflects an ongoing but cautious recovery in domestic demand, with mixed signals across different sectors. While non-food prices continue to grow, the persistent decline in food prices and falling transport costs highlight underlying challenges in the economy.

CHINA'S GREEN ENERGY TRANSITION: OPPORTUNITIES FOR FOREIGN INVESTMENT

In March 2024, China's ambitious push towards green energy was creating significant opportunities for foreign investors. As the country aims to achieve its carbon neutrality target by 2060, it is rapidly expanding its renewable energy capacity and revising policies to attract foreign investment.

POLICY FRAMEWORK AND TARGETS

China's National Energy Administration (NEA) is spearheading the transition by setting aggressive renewable energy targets. The country plans to install 500 gigawatts (GW) of wind and solar power by 2025 and increase this to 700 GW by 2030, aiming to reach a total installed capacity of 1,700 GW in these sectors. This expansion is part of broader efforts to decarbonize the energy sector, which accounts for over half of China's carbon emissions.

The government has also introduced the 2024 Green Industry Catalogue, which outlines eligible green projects and activities, providing a clear framework for investors. This move aligns China's green finance standards more closely with international norms, enhancing transparency and reducing the risk of greenwashing.

INVESTMENT OPPORTUNITIES

Renewable Energy: Foreign investors can tap into China's burgeoning renewable energy market, particularly in solar and wind power. The country's vast desert regions are slated for large-scale solar and wind farms, offering substantial opportunities for investment in these projects. The plan to build 455 GW of solar and wind capacity in desert areas by 2030

includes significant roles for foreign capital and expertise.

Green Finance: The government is also promoting green bonds, with updated guidelines aimed at increasing the attractiveness of these financial instruments to international investors. By 2022, foreign institutional investors gained unrestricted access to China's securities market, a crucial step for boosting foreign participation in green finance.

Beyond direct energy projects, there are opportunities in green building, smart grids, and sustainable urban development. China's push for energy-efficient buildings and smart city projects opens avenues for foreign firms specializing in these technologies.

REGULATORY AND MARKET DEVELOPMENTS

The government is rolling back some advantages previously enjoyed by domestic companies, levelling the playing field for foreign investors. This includes more transparent procurement practices and improved access to financing for foreign firms. The Catalogue of Encouraged Industries for Foreign Investment has been updated to include

numerous green sectors, emphasizing renewable energy, clean production, waste management, and sustainable infrastructure.

CHALLENGES AND CONSIDERATIONS


Despite these opportunities, investors must navigate challenges such as regulatory complexities and market competition from dominant state-owned enterprises. However, **Sustainable Infrastructure:** the central government's strong commitment to its green transition goals provides a stable policy environment that mitigates some of these risks.

STRATEGIC IMPORTANCE

China's renewable energy push is not just about meeting domestic energy needs; it is also a strategic move to reduce dependence on coal and enhance energy security This shift is crucial as geopolitical tensions and environmental concerns make sustainable energy more vital than ever. Moreover, China's efforts to align its green policies with global standards facilitate greater international collaboration and investment.







CHINA'S KEY PLENUM AIMS TO RESOLVE DECADES-OLD TAX REVENUE IMBALANCES

Changes to China's tax system will focus on allowing local governments to retain more fiscal revenues, say policy advisers, widely seen as an important step towards removing an immediate threat to financial stability.

An addiction to land sales exposed by China's property crisis will be the focus of a leadership gathering in July.

Reforms to boost local government revenue are being pushed after the land finance phase. Three of them requested anonymity because the matter is sensitive.

The biggest changes to China's fiscal system in three decades will involve a massive \$13 trillion local

government debt pile that poses dangers for financial institutions and economic expansion.

Local governments' fiscal revenues accounted for 54% of the nation's total, according to the finance ministry.

China aimed to limit localities' capacity to independently raise money after a surge in local spending and inflation in the late 1980s, which led to this imbalance.

Beijing is cracking down on off-budget financing vehicles and auctioning off land for residential development, which fuelled a massive housing bubble.

Land sales contributed to local

budgets by one fifth in the decade preceding 2021, when China entered a severe property market slump. In 2023, such incomes shrank to 5.8 trillion yuan (\$780 billion) from a peak of 8.7 trillion in 2021.

Chinese leaders did not provide details about plans for fiscal reforms at an annual meeting in December.

The main changes are likely to revolve around how much revenue local governments retain, rather than adding or hiking taxes, according to policy advisers.

Half of the revenue from value-added taxes and 40% of personal income taxes are currently received by municipalities, while the central government receives the majority of corporate income taxes and all of the consumption tax.

There are structural imbalances that the fiscal overhaul is unlikely to address, such as an over-reliance on investment and exports.

Gains from assets are subject to a 20% tax in China. The percentage is lower than the 30% in India and 37% in the U.S., despite numerous exceptions.

However, investment yields are dwindling, as evidenced by debt significantly outgrowing China's gross domestic product (GDP) for the past 15 years.

Tax revenue is low because of this. The International Monetary Fund estimates that China's tax-to-GDP ratio is 14%, compared to a 23% average for the Group of Seven developed nations.

Social spending is difficult to fund without raising taxes on capital or businesses. China's upper personal income tax band is among the world's steepest, at 45%, making it more difficult to tax households.

Labour and capital are taxed differently to encourage low wages and big investments.

Reversing that goes against Beijing's goal of establishing global industrial and technological dominance, which prioritizes the allocation of resources to factories and research labs rather than to end users.

The China Academy of New Supply-Side Economics' founder president, Jia Kang, believes tax reforms should aid industrial growth. China needed to grow the pie, he said.

One seed for a longer-term tilt towards consumption may be planted at the plenum.

The consumption tax may be charged to wholesalers and retailers, according to Chinese media. This tax currently only applies to 15 types of goods, including alcohol and tobacco, luxury cars, jewellery and yachts. China's productivity has not been affected by domestic demand for these items.

Analysts from Goldman Sachs say charging consumers shifts the focus of local officials from building their manufacturing base to serving the public. However, that would require a broader application of the tax at a time when consumption is weak and the economy is fragile. There are compelling reasons for increasing the role of consumption tax, but implementation is likely to be incremental.

The same restrictions apply to the addition of a property tax. China had long intended to introduce the levy in order to reduce the regressiveness of its tax regime, but the property crisis derailed those plans. "Beijing will not kick the sector while it's down." Jia said. "We can move only at an appropriate opportunity."

Perth, the capital city of Western Australia, is a beautiful tourist destination with white sand beaches and adventure sports facilities. VISA POLICY

All tourists, except those who are citizens of 36 eVisitor countries, which include 27 EU countries, UK citizens, and 34 ETA (Electronic Travel Authority) countries, require a visa to enter Australia. Citizens from New Zealand with valid passports can enter Australia without a visa. The tourist visa is valid for three, six, or twelve months.

HOW TO TRAVEL TO PERTH

By air

For international tourists, the best way to reach Perth is by air. The Perth international airport is approximately 14 kilometres from the City West Centre. Perth and all Australian disembarkation points are most likely the world's most remote airports. If you are flying from the USA or EU, the journey will take more than 21-25 hours, including stopover time.

By road

Tourists disembarking at other international ports in Australia can travel to Perth by road or railway. There are no regular long-distance coach services, but people can go on adventurous trips from other major Australian cities, especially from Adelaide.

Bv rail

Trans-continental train services are available between Sydney and Perth via Kalgoorlie and Adelaide, which will be a four-day journey.

By sea

Many cruise services dock at Fremantle, making it a convenient option for tourists who like sea voyages. The trip will be expensive, but the cruise will be a wonderful experience.





Public transport (bus service, Metrorail network, ferry, and taxi services) is the easiest means to move around the city. You can hail or call a taxi at your convenience. Ferry services make it easy to move across the Swan Riverthat runs through the centre of Perth.

THE BEST LOCATIONS TO VISIT

The Perth Mint

The Perth Mint, established on June 20, 1899, is a wholly-owned government institution and Western Australia's official bullion mint. It is located within 2 kilometres of Perth's city centre. The mint was established two years before the formation of the Federation of Australia. It was established to refine gold for the British Empire, and it was one of the last three Australian colonial branches of the UK's Royal Mint. It is one of the oldest mints in the world. Tourists can watch the minting process, and purchase souvenirs, gold nuggets, collector's coins and many other gift items from the Perth Mint shop. The world's largest and heaviest gold bullion coin is also displayed here.

Entry fee: US\$19 per head. Children and students get concession rates.

Adventure World

Adventure World is located in Bibra Lake, which is 20 kilometres from Perth. It is an exciting entertainment centre blending adventure and water rides. The park was built on a limestone quarry and offers 25 different types of entertainment activities, which include a roller coaster, a tall, steep funnel water slide, Hawaiian-themed aquatic activities, etc. The theme park is open to the public for 7 months, but closed during the winter.

Rates will vary per season. Peak season rates will be \$1.00 higher than off-peak rates. Children pay \$94.95 per head, and adults pay \$86.95 per head. Seniors (above 60) pay \$25 per head.

Penguin Island

Penguin Island is located 660 metres from Shoal Water Marine Park, which is reachable in a 5-minute ferry ride from coastal Perth. The island's main draws are its pristine white sandy beaches and wildlife, particularly the little penguins. Besides, the penguins, you can find nesting seabirds and pelicans. Other interesting points of interest are Pelican Bluff, Abalone Point, South Beach, and Surfers Beach.

The Aquarium of Western Australia

If you want to engage in a thrilling underwater trip, visit the Aquarium of Western Australia (AQWA). There you will have fascinating opportunities to watch various forms of marine life and unique coral life. The aquarium is divided into five segments, each with its own unique theme representing Australian marine life. Besides visiting the aquarium, tourists can engage in snorkelling, diving, and journeying through the underwater tunnel. The aquarium is approximately 22 kilometres from Perth city centre.

The Bell Tower

With its signature eighteen bell peals, the Bell Tower in Perth is an iconic landmark in the city and a unique modern construction marvel. The Bell Tower is located on the banks of the Swan River and was presented to Western Australia during the bicentennial celebrations in 1988. It is also known as the



Swan Bell and was createdby the famous Australian architect Hames Sharely.

The space-age design reflects modern Australia, and each tile comes from a school in Western Australia, with each child having carved his or her name as their contribution to the tower. Tourists can climb to the top deck of the tower and experience the panoramic view of the city and the surrounding landscape.

THE EU IS **THREATENING** A TARIFF HIKE ON CHINESE **ELECTRIC VEHICLES**

The European Union will raise tariffs on Chinese electric vehicles (EVs) unless Beijing agrees to a "solution" to subsidies that the bloc says are causing its markets to be distorted.

The European Commission has said that they will increase the taxes on Chinese car companies to 38%, instead of the current 10%. This will happen on July 4, unless they can solve the problem with China's subsidies. The dispute over EVs is the latest in a series of trade disputes between the EU

In a press release, the EU said they talked to Chinese officials about their investigation into the subsidies and found ways to fix the problems.

The new taxes will start on July 4th if talks with the Chinese authorities don't work out. The EU's action was expected amid an investigation into China's state support for its automakers, who have taken advantage of the 10% tariff.

The commission says Chinese-built EVs are 20% cheaper than European ones and that has helped imports of EVs into the EU skyrocket in recent years. Imports include vehicles from Western brands like Tesla and BMW that are made in China. The EU says that Chinese brands, such as BYD and SAIC, are also increasing their market share because Beijing's huge subsidies help them beat European brands on price.

The EU says China is unfairly supporting green tech exports, including solar panels, batteries and wind turbines. Some people took the commission's announcement in their stride. Cui Dongshu, secretary of the China Passenger Car Association, said: "The EU's provisional tariffs are in line with our expectations, which won't affect most Chinese firms much."

Nio, a company that makes electric cars in China, said it doesn't agree with the plan, but it still wants to sell them in Europe. However, some people were upset by the news, especially in Germany, which has the biggest car industry in Europe.

Germany's transport minister said that the EU's planned tariff hike could lead to a "trade war" with China. The European Union's punitive tariffs hit German companies and their top products. Volker Wissing said on X that cars should become cheaper by having more competition, open markets, and better business conditions in the EU. He doesn't want trade wars, nor to be or be isolated from markets.

"As a country that exports things, we don't need more barriers to trade. We should work to get rid of trade barriers in the spirit of the World Trade Organization," said Ola Kaellenius, CEO of German carmaker Mercedes Benz.

EU SUBSIDY PROBE IS HURTING CHINA'S DESIRE TO INVEST IN EUROPE

A study of Chinese electric car companies found that the investigation by the European Union hurt their sales and made them less likely to invest in Europe.

The China Chamber of Commerce survey showed that 82% of vehicle and industry chain firms said that the subsidy investigation had made them less confident about investing in Europe. The survey was done in April and May as part of a report about electric car companies in China and Europe. 73% of the respondents said that sales in Europe had decreased because of the investigation.

Most companies said that their collaboration with European partners. such as distributors and leasing companies, was delayed or scaled back, and that the EU probe hurt the image of their brands in Europe, making it harder to attract top European talent.

The European Commission said it would impose supplementary duties of up to 38.1% on Chinese producers like BYD, Geely, and SAIC, as well as on Chinese-built cars of Tesla and other Western automakers

Chinese car companies want Beijing to charge more taxes on European cars that use gasoline, the Global Times reported.

The study showed that Chinese companies making electric cars still think Europe is important and plan to build factories there within the next five

The report said that companies have been trying to become more localized in Europe for a long time, but the EU's actions have made them less interested.

CHINA HAS TARGETED EUROPE'S FARMERS, NOT ITS AUTOMAKERS, IN RESPONSE TO EU TARIFFS ON ELECTRIC CARS

After the EU said it will impose temporary tariffs on Chinese electric cars, the Commerce Ministry has said they are investigating imports of pork from Europe for anti-dumping. People think this is a response to the EU's move on electric cars. It gives China a bargaining chip in trade negotiations.

The EU will look into the import of pork from other countries. This includes fresh and frozen pork meat, intestines, and other parts of the body. The announcement says that it will take one year, with a possibility of a six-month

In 2020, EU exports of pork products to China hit a high of 7.4 billion euros (\$7.9 billion) Since then, they have dropped, reaching 2.5 billion euros (\$2.6 billion) last year. Half of that came from Spain.

Olof Gill, who works for the European Commission on trade, told reporters in Brussels that EU farm subsidies follow the rules set by the World Trade Organization. The commission will monitor the investigation and help if

China could have taxed gasolinepowered cars with big engines by 25% to fight climate change, which would have hurt Mercedes and BMW considerably. At least for now, the government may be acknowledging that the German auto industry is opposed to the EU tariffs and its large production in China.

The EU tariff announcement on June 12 was a step away from global cooperation. Hildegard Müller said in a statement that the risk of a global trade conflict is rising further as a result of this measure.

Chinese officials say that the EU is investigating subsidies for electric car production in China, which goes against WTO rules. The EU will impose tariffs on EVs from China for four months, starting July 4. The tariffs would apply to cars made by Chinese and foreign companies, like Tesla, that are sent to Europe.

Spanish Economy Minister Carlos Cuerpo said there is a need to avoid making trade problems worse.

Luis Planas, Spain's Minister of Agriculture, said that the agricultural industry often pays the price for conflicts, such as the United States' imposition of tariffs on some EU farming products in 2019. Planas said that there is time and space to negotiate and try to avoid this trade conflict.





CHINESE PROPERTY MEASURES BOOST SALES ONLY IN BIG CITIES

There is more trouble for the bulk of the country's real estate sector because of the recent property support measures in China.

China slashed minimum mortgage rates and down payments on May 17th, easing regulations in dozens of cities.

The small amounts of transaction data and interviews with ten real estate agents across China show that the measures had a mixed effect, reviving interest in big cities like Beijing and Shanghai, but not smaller ones.

In smaller cities, where the quantum of excess supply is far greater than in larger cities, there are concerns that the downturn may run on.

Before exploding in 2021, the real estate sector accounted for a quarter of the country's gross domestic product.

Demand and supply are more balanced, according to the chief economist at Pinpoint Asset Management.

Fixing the enduring structural oversupply issue in numerous small towns is more

challenging than fixing the underlying structural oversupply issue. It will take longer to complete.

Experts say that the smaller city governments should get more money to reduce inventory and stabilize those markets, though they're cautious about bailing out reckless developers.

Between May 18 and June 5, the average daily transaction for second-hand homes in Shanghai was 27.7% higher than the April average, whereas it was 8.0% higher in Beijing. Older apartments in Beijing

and Shanghai sell faster because they are in better areas, according to agents.

The city relaxed down payment requirements, according to one agent in Shanghai, and another agent said house tours increased by 60%

According to transaction data released by the China Index Academy, there was a decline of 16% year-on-year for a group of 30 cities, including the largest ones.

Buyers are still wary of cash-strapped developers not being able to complete projects, and sales in smaller cities are still weak.

The assistant China research director at Gavekal Dragonomics said that smaller cities are doing a lot to get people to buy more houses. Agents say the most aggressive cities haven't succeeded in reviving interest.

The 15% new down payment limit for some buyers was split into two 7.5% instalments up to two years apart in order to boost supply from those who wanted a place to live but didn't have a lot of cash. Deposits in Shanghai and Beijing are 20% and 30%, respectively.

The effect was not noticed by real estate agents. As before, the workload is the same. Even though they get more inquiries, there aren't many people booking property tours. Agents might get more inquiries, but not many people actually book property tours.

Developers in the central city of Changsha, home to around 10 million people, instructed to refund deposits without condition if buyers changed their mind before finalizing the deal. Statistic shows that fewer people are interested in purchasing homes. A

Changsha agent named Xu says the new policies are being implemented because the market is in trouble.

Goldman Sachs experts expect further relaxations in the upcoming months. The upcoming L-shaped recovery in the sector may be the result of persistent property weakness related to lower-tier cities and private developers, they say.

CHINA'S EV INDUSTRY DRIVING GLOBAL GREEN DEVELOPMENT

China's electric vehicle (EV) industry is rapidly advancing, playing a crucial role in driving global green development. As the world shifts from "global warming" to "global boiling," the adoption of new energy vehicles (NEVs), including battery electric vehicles (BEVs) and plug-in hybrid EVs, is essential for reducing emissions. Unlike traditional vehicles, EVs run on rechargeable electric batteries, producing no tailpipe emissions and operating without a combustion engine.

In 2023, approximately 13.6 million EVs were sold worldwide, with global sales expected to grow by 25-30% this year. McKinsey predicts a six-fold increase in worldwide EV demand from 2021 to 2030. BEVs and plug-in hybrid EVs made up 15.8% of global light vehicle sales last year, with China leading the market, followed by the Nordic countries.

China produced and sold the highest number of EVs in 2023 (9.58 million and 9.49 million units, respectively) and exported 1.2 million EVs. Projections for this year indicate production of 11.5 million and exports of 5.5 million EVs.

China's success in the EV market is driven by quality and performance rather than overcapacity. Critics should acknowledge that China's market economy status and its growing market share result from natural market forces and healthy competition.

The country has invested heavily in EV technology and developed efficient production processes and supply chains. Special industry clusters in regions like the Yangtze River Delta and Pearl River Delta have further enhanced its manufacturing capabilities.

China's EV sector significantly contributes to global technological development. Over the past decade, massive investments in EV technology have led to advancements in battery technology, which have been pivotal for the industry.

China's battery manufacturing value chain is now the largest in the world. Chinese EV-makers are also

investing billions in smart car features, integrating Al-powered systems, voice recognition, and automated parking. They are creating a "Human x Car x Home" ecosystem, connecting EVs to phones and home appliances, offering feature-rich vehicles at competitive prices with strong after-sales support.

Despite China's contributions to green development and technological innovation, some US and European politicians criticize its EV sector, claiming national security concerns. However, such accusations often mask economic protectionism.

The European Commission has launched an anti-subsidy investigation into EV imports to restrict Chinese EVs, while the US complains about oversupply. Nonetheless, as long as consumers in developed economies

are satisfied with Chinese EVs, it will be challenging to curb China's dominance in the global EV market.

Competitors should adhere to market rules and ensure a level playing field. BYD, a Chinese EV-maker, overtook Tesla as the world's largest EV producer last year, and China became the world's largest car exporter, surpassing Japan. Instead of economic bullying, US and EU politicians should embrace open market competition, allowing consumers to decide which products to purchase. Elon Musk's increased investment in the Chinese market exemplifies healthy competition and collaboration in the global EV sector.

CHINA'S NEW MEASURES TO SUPPORT FOREIGN INVESTMENT IN SCI-TECH FIRMS

China has introduced new measures to attract foreign investment in its tech sector, as announced by the China's Ministry of Commerce (MOFCOM), along with nine other departments.

The initiatives aim to ease restrictions, promote collaboration, and improve the investment environment.

Key steps include facilitating RMB bond issuance by eligible overseas institutions, encouraging tech companies to raise funds through bonds, and streamlining foreign investment via the Qualified Foreign Limited Partner (QFLP) scheme.

The government will also expedite license approvals for the Qualified Foreign Institutional Investor (QFII) and Renminbi Qualified Foreign Institutional Investor(RQFII) programs.

These efforts aim to attract fresh capital to China's science and technology sectors in response to outbound investment restrictions imposed by the US.

OCBC DOUBLES DOWN ON GREATER CHINA GROWTH, AIMS TO INVEST HK\$1.5 BILLION INTO ITS TECH AND FACILITIES IN THE REGION

Oversea-Chinese Banking Corp (OCBC) plans to invest HK\$1.5 billion (S\$259.1 million) in technology and facilities across Greater China over the next three years. This investment aims to modernize technology platforms, channels, and products. The bank will also expand its regional engineering hub, hiring 300 new talents. Group CEO Helen Wong highlighted China's economic growth as a key driver for the region. The bank's Greater China assets total \$\$95 billion, contributing significantly to its profits with a 24% annual growth over the past decade. OCBC aims to achieve HK\$3 billion in revenue from its Asean-Greater China strategy by 2025. The investment includes HK\$1 billion for technology modernization and HK\$500 million for workplace upgrades, including a new office lease in Hong Kong. Additionally, its private banking arm, BOS, targets 50% growth in assets under management in Hong Kong by 2026.

CHINA SIGNIFICANTLY INCREASING GOLD PURCHASES

Chinese investors, wary of real estate and stocks, are driving global gold prices to record highs, with prices surpassing \$2,400 per ounce.

Consumers like Xena Lin, 25, are buying affordable gold "beans," while the central bank boosts its gold reserves to reduce reliance on U.S. dollars. Gold consumption in China rose 6% in the first quarter, following a 9% increase last year.

Despite higher interest rates and a strong U.S. dollar, gold prices remain high, driven by Chinese demand. The central bank's aggressive buying has made China a dominant force in the gold market.

ASEAN TOURISM TO CHINA JUMPS AFTER VISA RULES EASE



China is becoming a top destination for Southeast Asian tourists, thanks to new visa-free entry programs and easier access to cashless payment systems, reports Klook Travel Technology.

CEO Ethan Lin noted that reservations from Southeast Asia in 2024 are much higher than pre-pandemic levels.

Visa restrictions have been relaxed for visitors from Thailand, Malaysia, and Singapore, boosting tourism.

CHINESE AUTHORITIES ORDER SMALL BANKS TO CURTAIL THEIR WEALTH MANAGEMENT BUSINESS

To reduce financial dangers, China's banking supervisor has given small banks until 2026 to stop marketing wealth management solutions.

Banks were required to establish a wealth management subsidiary dedicated to such products, but the regulator didn't give a timeline for when they had to comply. The latest instruction says that some small banks must reduce their wealth management business activities by the end of the year.

Small regional lenders in Shandong, Guangdong, and Zhejiang provinces have been instructed by the National Financial Regulatory Administration to reduce their wealth management operations, according to sources. A regulatory crackdown on shadow banking activities in recent years has led to the government's latest attempt to control risks in the spherical bank wealth management sector. Banks would need to standardize wealth management businesses and invest the funds into capital markets.

A clear separation between banks wealth management operations and their other businesses will eliminate any implied guarantee that these investment products will be bailed out by the banks if they perform poorly.


